The role will work closely with cross-functional teams to assist in improving and developing production processes & procedures, implement new product innovations and ensure quality standards are consistently met. Main areas of focus are:

- Managing NPD/EPD launches
- Improving existing and developing new processes
- Product & Material reformulation

### **Key responsibilities:**

#### **♥** Product Process Support

To manage the delivery of development projects from concept approval Gate 3 to launch delivery Gate 6. Collaborate with Innovation teams to identify opportunities for NPD, modifications and improvements.

#### Process Improvement & Optimisation

Analyse current manufacturing processes and recommend improvements to the Site Process Manager to enhance productivity, improve quality and reduce waste in the business.

Manage trials under the guidance of the Site Process Manager to validate process improvements and new product formulations.

Support the implementation of process changes by testing and refining processes, ensuring efficiency, consistency, and sustainability and feed back findings to Site Process Manager.

#### **♥** Quality Assurance & Compliance

Work closely with the Site Process Manager and Technical teams in maintaining the quality management systems and processes in line with legal, customer, company and other best practice requirements which create, maintain and improve the integrity and food safety and quality of all products manufactured.

# **General Profile:**

The Senior Process Development Technologist will be supporting product innovation and continuous improvement within Yeo Valley's yogurt, ice cream, dessert, savoury & fruit product lines. This role requires practical and conceptual knowledge in process development, alongside a basic understanding of related disciplines such as product innovation, technical development, and production. The Senior Process Development Technologist will be responsible for conducting factory trials, improving existing processes. Working with minimal supervision, they will independently address technical challenges. Additionally, they will be a key resource for less experienced colleagues, providing guidance & sharing knowledge.

**Business Expertise:** The Senior Process Development Technologist has a grasp of industry best practices in process development and understands how their work integrates with cross-functional teams.. The Senior Process Development Technologist's ability to understand both the technical and

**Leadership:** While the primary responsibility will be hands-on technical work, the Senior Process Development Technologist can lead small scale projects and trials or specific workstreams. In addition to overseeing their own projects, they will demonstrate mentoring guidance to the Process Technologists and provide advice to solve challenges and achieve project milestones. The role requires them to identify technical and operational challenges, apply innovative solutions, and recognise how these decisions affect the broader product development process.

Impact: Guided by department policies and overall product development plans, the Senior Process Development Technologist will impact a range of operational and technical activities within the team and across related departments. Their work on factory trials, process improvements, and NPD/EPD launches will be essential to meeting service and quality goals while ensuring the efficient scaling of new and existing products. By improving processes and contributing to the launch of innovative products, the Senior Process Development Technologist will play a role in Yeo Valley's ability to deliver high-quality products that meet customer expectations.

**Interpersonal Skills:** The Senior Process Development Technologist must possess clear and fluent communication skills to explain complex technical information clearly to both technical and non-technical stakeholders. This includes sharing sensitive information and navigating challenging situations with tact and professionalism. As a key member of the product development team, they will guide others, both within the organisation and potentially with external partners, to adopt best practices and innovative solutions.
